VENDOR / CONCESSIONAIRE GUIDELINES

- ★ Vendor Contact: Lee Nunnally - (434) 531-0864 or Horse Show Office (540) 687-5740
- ★ Provide a **current copy of Certificate of General Liability Insurance** with the Upperville Colt & Horse Show, Inc. listed as an additional insured prior to set-up.
- ★ Food Vendors must comply with Loudoun (Jumper Side) or Fauquier (Hunter Side) County Health Department regulations. Licenses and permits for operation on the show grounds are vendor's responsibility.
- ★ Weekly vendors must set up Saturday or Sunday (May 30th or 31st)
- ★ Vendors with mobile unit / sales trailer must coordinate their set-up / parking day and time with Lee Nunnally prior to arrival.
- ★ Vendors are asked to be open on the weekdays between 10 am and 4 pm or until the end of the show day.
- ★ The Vendor Village area will be set up on the Jumper side on Sunday. If you rent a tent from VA Tent rentals, you have the option to move to the Vendor Village on Saturday evening to take advantage of the Sunday crowd. There is a tent move charge but no additional cost for the space. **Only Virginia Tent Rental tents are allowed in the vendor village.**
- ★ For horse safety reasons, no vendor owned tents – only approved Virginia Tent Rental tents will be allowed in certain vendor areas.
- ★ All tents are subject to safety inspection and may be **REJECTED by Management** if deemed unsuitable. The same applies to any mobile unit / sales trailer occupying a vendor / concession space.
